Objective of the company



General Objectives

- (1) To purchase, supply, accept, hire, buy or hire-purchase, acquire ownership, occupy, modify, utilize, and manage by other means any property as well as interest accruing thereon;
- (2) To sell, transfer, mortgage, pledge as security, trade and dispose by other means of properties;
- (3) To act as brokers, representatives, agents for enterprises and business of all kinds, except for insurance business, recruiting member for associations and securities trading;
- (4) To borrow money from, overdraw on accounts with banks, corporations or other financial institutions; and to lend or give credit by other means, with or without collateral securities, as well as to accept, issue, make a transfer and endorse bills of exchange or other title-transferable bills or instruments;
- (5) To set up branches or appoint agents to operate both inside and outside of the country;
- (6) To enter as a partner into limited-liability partnership ventures and as shareholder into other limited companies;

Commercial objectives

- (7) To trade live animal, dissected animal, butchered meat, frozen meat, and canned meat.
- (8) To trade rice and its products, corn, cassava, cassava pellet, coffee, cashew, nut, sesame, castor bean, oil palm, jute, cotton, all type of farm plants and their products, lac, animal skin and horn, timber, ore, resin, latex, rubber sheet, or other types of product from rubber trees from herb forest and all kind of crops products.
- (9) To trade vegetable, fruit, bamboo shoot, pepper, horticulture, cigarette, tobacco, beverage, drinking water, mineral water, juice, liquor, beer, fresh food, dried food, instant food, canned seafood, canned food, seasoning, sauce, sugar, vegetable oil, animal feed, and other comestibles.
- (10) To trade clothing, synthetic fabrics clothing, thread, elastic thread, nylon thread, synthetic fiber, rubber thread, clothes, clothing, outfit, dress, socks, stocking, leather, shoes, bags, other consumer goods, textiles, including all sporting equipment.
- (11) To trade houseware, household furnishing, glassware, kitchenware, refrigerator, air conditioner, air purifier, fan, air vacuum, electric rice cooker, electric iron, heater, cooler, microwave oven, electric appliances, electrical equipments, and related equipments including spare parts.
- (12) To trade materials, equipments, and all kinds of tool for construction, color, painting tools, building decorations, metalware, copperware, brass, enamelware, sanitary ware, plumbing equipments, and related equipments including spare parts.
- (13) To trade machinery, motor engine, mechanism, labour saving device, vehicle, generator, water pumps, water treatment equipments, and garbage disposal.
- (14) To trade fuel, coal, other energy producing products, and to operate business of fuel station.
- (15) To trade pill, medicine, pharmaceuticals, chemical substance, medical devices, scientific equipments, fertilizer, herbicide, plant tonic, and veterinary drug.
- (16) To trade cosmetics, beauty equipments and supplies.
- (17) To trade paper, stationeries, textbooks, print media, books, education equipments, camera, video recorder, calculator, printer, printing equipments, newspaper, file cabinet, office equipments, communication devices, computer, and related equipment including spare parts.
- (18) To trade gold, copper alloy, silver, diamond, gem, and other jewel, including their synthetic products.
- (19) To trade plastic goods or the like, both in form of raw material or finished plastic products.
- (20) To trade synthetic rubber, synthetic substance of related products using scientific processes.
- (21) To import and export those products listed in the objectives for benefits.
- (22) To hold auctions to sell products listed in the objectives to person, (non-juristic) body of person, Juristic Person, and domestic and oversea government and government's departments.
